





Information Booklet For **Under Graduate (MBBS) Students**

Agartala Govt. Medical College (AGMC) was established in 2005 to meet the medical need of the State and to impart a high standard of Medical Education and Service to our State and the other North Eastern parts of the country. With that perspective, along with students of our state, a good number of students from other states are admitted in Agartala Govt. Medical College every year. It helps interaction of our students with the students of other states having diverse cultures, standards, food habits, languages and grows a healthy sense of competitive attitude and National Integrity amongst them, as a member of the same family of AGMC.

The Under Graduate Course and Post Graduate Courses in 15 Nos. of disciplines are conducted in Agartala Govt. Medical College.

Under Graduate

This year 125 students are admitted in this College. Out of 125 seats, 96 seats are filled up by the students of Tripura, 19 seats by the Central Govt. nominee and 10 seats by nominee of North Eastern States namely Mizoram (2 seats), Meghalaya (3 seats), Arunachal Pradesh (2 seats) and Nagaland (3 seats).

Undergraduate teaching, training, syllabus, courses, examinations etc. are carried out according to the rules and regulations of the Tripura University and as per Medical Council of India guidelines. Students are awarded MBBS degree on completion of 4 ½ years undergraduate education by Tripura University (A Central University).

Eligibility for Admission for M.B.B.S. Course :

- a) Age A candidate who has completed the age of 17 years on or before 31st December of the corresponding year is eligible for admission. Date of birth as recorded in the Madhyamik / 10th Standard / School Leaving Certificate issued by the concerned Board of Education will be taken as authentic.
- b) Educational qualification Candidates must have passed the Higher Secondary Examination or the Indian School Certificate Examination which is equivalent to 10+2 Higher Secondary Examination after a period of 12 years of study, the last two years of study comprising of Physics, Chemistry and Biology or any other elective subjects with English at a level not less than core course of English as prescribed by the National Council of Educational Research and Training after the introduction of the 10+2+3 years educational structure as recommended by the National Committee on education. All or any such examination must be recognized by the Tripura University for the purpose of admission.

A candidate must have passed in the subjects of Physics, Chemistry, Biology/ Biotechnology and English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry, Biology/ Biotechnology at the qualifying examination. In respect of candidates belonging to Scheduled Castes/Scheduled Tribes, the marks obtained in Physics, Chemistry, Biology/ Biotechnology taken together in qualifying examination be 40% instead of 50% as stated above.



The candidate should pass individually in English, Physics, Chemistry and Biology and obtained minimum 50% (fifty percent) marks taken together in Physics, Chemistry and Biology in qualifying examination. In respect of candidates belonging to Scheduled Castes, Scheduled Tribes or other backward Classes, the marks obtained in Physics, Chemistry and Biology taken together in qualifying examination may be 40% (forty percent) instead of 50% (fifty percent).

- c) Verification of documents All admissions are subject to verification of the original certificates / documents produced by the candidates. Regarding the eligibility of any applicant, the decision of *the appropriate authorities* as per the MCI guideline shall be final.
- **d)** Medical fitness All admissions are subject to Medical Fitness of the candidate.

- (i) All Students except the newly admitted students must pay fee by the date fixed by the college authorities.
- (ii) A concession of 25% in the Tuition Fees only shall be made for students belonging to BPL families.

For students opting to discontinue studies :

- 1. Within a week of commencement of classes, 90% of the tuition fees shall be refunded, while 10% shall be retained by the college as administrative and other charges. Other fees shall be refunded after proportionate deduction.
- 2. After one week but before one month of commencement of classes, 50 % of the tuition fees shall be refunded, while 50% shall be retained by the authority as administrative and other charges. Other fees shall be refunded after proportionate deduction.
- 3. After one month, no fees shall be refunded.
- 4. After one month of commencement of classes (except outside candidates of the State), the concerned student will be liable to pay the tuition fees for the entire course and only after which he/she will be eligible to receive a transfer certificate and other documents deposited at the time of admission.
- (iii) As per the Medical Council of India Regulations, the admissions will be closed by the Medical Counseling Committee. If any MBBS student discontinues the studies after this period, he / she will be liable to pay the tuition fee for the entire course. In such cases, the transfer certificate will be issued and other documents returned only after payment of tuition fee for the entire course is made.
- (iv) If any student discontinues the studies after one month of joining, he/she will be liable to pay the tuition fees for the entire course. In such cases the transfer certificate will be issued and other documents returned only after payment of tuition fees for the entire course.
- (v) Migration to and from this College will be as per the guidelines laid down by MCI and as amended from time to time.
- (vi) No Student shall report any matter of the College and Hospital to the Press, Police and Public without taking prior permission from the Principal of the College.
- (vii) Every student must carry the I dentity Card duly signed by the Principal of the College.

DRESS CODE

College uniform and sports dress would be worn during college hours and while on college play ground respectively.

DISCIPLINE



- 1. Ragging, in any form is prohibited and shall not be tolerated at all.
- It is expected that all students shall dress, behave and conduct themselves inside and outside the College in a manner befitting a medical student who shall one day become a respected member of society.
- 3. Students should always be polite and considerate of others especially to the fellow students, patients and their relatives, Teachers and other Staff members of the College.
- 4. During Class hours all students shall wear a white full sleeved apron over their Uniform throughout the course.
- 5. Students shall not use mobile phones during College hours & Examinations.
- 6. Consumption of alcoholic drinks, smoking and any form of intoxication is completely prohibited in the College and Hospital Campus.
- 7. Any breach of discipline or failure to carry out the orders of the Principal shall be dealt with strictly and might even result in expulsion of the student from the College and/or filing of an FIR at the police station.
- 8. The rules and regulations as prescribed and displayed in the hostel would be strictly followed.
- 9. This is an Institution meant for higher learning and the objective is not only to impart education but also to build the character of the students and transform them into a better human being. Students are expected to observe absolute discipline in their conduct during the entire period they spend in the institution. Failure to observe absolute discipline will invite appropriate disciplinary action.

Offences & Punishment

- For all offences committed in the College or Hospital premises the Principal may at his discretion refer the case to the College Disciplinary Committee, which shall have the power to investigate and recommend to the Principal, who may or may not seek the ratification of these recommendations.
- After considering the recommendations of the College Disciplinary Committee, if sought for, the Principal will take necessary disciplinary action including filing FIR with the local police against those who rag or abet ragging.

Ragging :

• Ragging is prohibited by law and order of the Hon'ble Supreme Court of India. The Medical Council of India has instituted clear-cut guidelines to curb the menace of ragging.

Ragging includes any or all of the following :

- Mental/ Physical / Sexual abuse
- Verbal abuse
- Violation of decency
- Criminal intimidation / Wrongful restraint
- Undermining human dignity
- Financial exploitation / Extortion
- Use of criminal force



(EACH OF THE ABOVE IS A CRIMINAL OFFENCE)

A student indulging in ragging can be :

- * Expelled from the institution
- * Banned from the Mess / Hostel
- * His / her scholarships can be withdrawn
- * Debarred from examinations
- * Debarred from admission to any institution
- * Criminally Prosecuted

However, Some Salient features of the course are given below:

Academic Calendar for MBBS Course :

Duration	 Four and half years
Compulsory Rotatory Internship	 One year
Total Duration	 4 ½ + 1 = 5 ½ years

Agartala Government Medical College conducts a four and a half years course followed by a one year period of compulsory rotating internship, which shall lead to the award of the M.B.B.S. degree by the Tripura University (A Central University). Students must secure at least 50% marks of the total marks (combined in theory and practical / clinical; not less than 40 % marks in theory and practical separately) assigned for internal assessment in a particular subject in order to be eligible for appearing in the final University examination of that subject. The period of 4 ½ years is divided as follows:

Pre-Clinical Phase (Phase I) - First Professional phase of 13 months preceded by Foundation Course of one month. Phase I will consist of preclinical subjects – Human Anatomy, Physiology, Biochemistry, introduction to Community Medicine, Humanities, Professional development including Attitude, Ethics & Communication (AETCOM) module and early clinical exposure.

Para-clinical phase (Phase II) - Second Professional (12 months) will consist of Para-clinical subjects namely Pathology, Pharmacology, Microbiology, Community Medicine, Forensic Medicine and Toxicology, Professional development including Attitude, Ethics & Communication (AETCOM) module and introduction to clinical subjects. A part of training during clinical postings should take place at the primary level of health care.

Clinical Phase – (Phase III) – Third Professional (28 months)

- Part I (13 months) The clinical subjects include General Medicine, General Surgery, Obstetrics & Gynaecology, Pediatrics, Orthopaedics, Dermatology, Otorhinolaryngology, Ophthalmology, Community Medicine, Forensic Medicine and Toxicology, Psychiatry, Respiratory Medicine, Radiodiagnosis & Radiotherapy and Anaesthesiology & Professional development including AETCOM module.
- (b) Electives (2 months) For diverse learning experiences, to do research/community projects that will stimulate enquiry, self-directed experimental learning and lateral thinking.
- (c) (c) Part II (13 months) Clinical subjects include :
 - Medicine and allied specialties (General Medicine, Psychiatry, Dermatology Venereology and Leprosy (DVL), Respiratory Medicine including Tuberculosis).
 - (ii) Surgery and allied specialties (General Surgery, Orthopedics [including trauma]), Dentistry, Physical Medicine and rehabilitation, Anaesthesiology and Radiodiagnosis)
 - (iii) Obstetrics and Gynecology (including Family Welfare)
 - (iv) Pediatrics
 - (v) AETCOM module

Attendance in the Class

- (1) Attendance requirements are 75% in theory and 80% in practical /clinical for eligibility to appear for the examinations in that subject. In subjects that are taught in more than one phase – the student must have 75% attendance in theory and 80% in practical in each phase of instruction in that subject.
- (2) If an examination comprises more than one subject (for e.g., General Surgery and allied branches), the candidate must have 75% attendance in each subject and 80% attendance in each clinical posting.
- (3) Students who do not have at least 75% attendance in the electives will not be eligible for the Third Professional - Part II examination.

University Examinations shall be held as under :

(a) First Professional

- The first Professional examination shall be held at the end of first Professional training (1+12 months), in the subjects of Human Anatomy, Physiology and Biochemistry.
- 2. A maximum number of four permissible attempts would be available to clear the first Professional University examination, whereby the first Professional course will have to be cleared within 4 years of admission to the said course. Partial attendance at any University examination shall be counted as an availed attempt.

(b) Second Professional

1. The second Professional examination shall be held at the end of second professional training (11 months), in the subjects of Pathology, Microbiology, and Pharmacology.

(c) Third Professional

- [1] Third Professional Part I shall be held at end of third Professional part 1 of training (12 months) in the subjects of Ophthalmology, Otorhinolaryngology, Community Medicine and Forensic Medicine and Toxicology
- [2] Third Professional Part II (Final Professional) examination shall be at the end of training (14 months including 2 months of electives) in the subjects of General Medicine, General Surgery, Obstetrics & Gynecology and Pediatrics. The discipline of Orthopedics, Anesthesiology, Dentistry and Radiodiagnosis will constitute 25% of the total theory marks incorporated as a separate section in paper II of General Surgery.

3. The discipline of Psychiatry and Dermatology, Venereology and Leprosy (DVL), Respiratory Medicine including Tuberculosis will constitute 25% of the total theory marks in General Medicine incorporated as a separate section in paper II of General Medicine.

Marks distribution for various subjects

In subjects that have two papers, the student must secure at least 40% marks in each of the papers with minimum 50% of marks in aggregate (both papers together) to pass in the said subject.

A student shall not be entitled to graduate later than ten (10) years of her/his joining the first MBBS course. No more than four attempts shall be allowed for a candidate to pass the first Professional examination. The total period for successful completion of first Professional course shall not exceed four (4) years. Partial attendance of examination in any subject shall be counted as an attempt.

A student, who fails in the second Professional examination, shall not be allowed to appear in third Professional Part I examination unless she/he passes all subjects of second Professional examination. Passing in third Professional (Part I) examination is not compulsory before starting part II training; however, passing of third Professional (Part I) is compulsory for being eligible for third Professional (Part II) examination.

Compulsory rotating internship (Phase IV)

Students will undergo compulsory rotating internship of one calendar year duration. No university examinations are held during this period. However assessment of work done by the student and his/her behavior and performance shall be monitored by the Head of the Department concerned as well as the Faculty member(s) under whom they are posted. Independent assessment shall be made by the Medical Superintendent of G. B. Pant Hospital and the Principal of the College. If they are all satisfied with the student's attendance, conduct, behaviour, knowledge and work including minimum skills acquired, they shall issue a certificate of satisfactory completion of internship. This is mandatorily required of the student from the College to obtain a Permanent Registration Certificate from the Medical Council of India without which they cannot practice medicine in India. During this period the interns are paid stipend by the College.

Rules of Hostel

- The hostel accommodation will be given to students seeking admission in the Medical College.
- There are separate hostels for boys and girls.
- Seats shall be allotted by the Hostel Superintendent.
- No boarder is allowed to change his/her seat or accommodation without special permission of the Hostel Superintendent.
- Students are expected to observe absolute discipline in their conduct during the entire period they spend in the hostel. Failure to observe absolute discipline will invite appropriate action.



- Smoking, drinking of alcohol and use of narcotics are strictly prohibited in the hostel.
- Ragging, in any form in AGMC Campus, is strictly prohibited.
- All students must attend the Roll Call daily at 8 P.M. No hostel inmate will be allowed to enter the hostel after 8 P.M. In case of any emergency, concerned student should take permission from the Hostel Superintendent.
- Student should take prior written permission (Night Pass) for leaving the hostel for overnight stay. Ordinarily night pass may be permitted to visit local guardians only on weekends.

If any student desires to leave hostel for his/her own ground, no refund will be given, the amount he/she had already paid.

Rules for Visitors in Hostels

- Visiting hours of the hostel : 4 P.M. to 6 P.M. daily.
- Student, should meet the visitor(s) only in the Visiting Room in presence of a hostel staff. No visitor/ guest will be allowed in the student's room.

Library facility

- The Library is under the control of Principal.

NOTIFICATION

It is for appraisal of all concerned, Under Graduate (UG) and Post Graduate (PG) Students of Medical Colleges of the State and outside the State,(domicile, sponsored and Central Government nominee) that a bond has to be executed and submitted in original in the office of the Director of Medical Education, Agartala, on being selected/admitted in the U.G and P.G. Courses as per the clauses as mentioned below:

1. All State candidates (domicile and sponsored) of Under Graduate and Post Graduate courses shall have to execute a Bond in favour of the State Government stating that he/she shall serve under Government of Tripura for a period of at least 5 (five) years immediately after successful completion of the course.

2. In case such candidates fail to serve under Government of Tripura as per Bond, he/she has to pay an amount of **Rs.20,00,000.00(Rupees twenty lac)** instead of existing amount of **Rs.5,00,000.00** (Rupees Five lac) for Under Graduate course and **Rs.35.00,000.00(Rupees Thirty five lac)** instead of existing amount of Rs. 25,00.000.00 (Rupees twenty five lac) for Post Graduate in Pre & Para-clinical subjects (Anatomy, Physiology, Biochemistry, Pharmacology, Pathology, Microbiology, Forensic Medicine & Community Medicine) and **Rs.50,00,000.00(Rupees Fifty lac**) instead of existing amount of Rs. 35,00,000.00 (Rupees thirty five lacs) in Clinical subjects (Medicine, Surgery, Orthopaedics, ENT, Obstetrics. & Gyanecology, Anaesthesiology, Paediatrics, Ophthalmology, Psychiatry, TB & Respiratory Diseases, Radio-diagnosis, Dermatology and Radiotherapy) to the Government of Tripura.

3. All Under Graduate and Post Graduate Students (domicile, sponsored and Central Government nominee) should execute a Bond stating that he/she will pay an amount of Rs. 20,00,000.00(Rupees twenty lacs) if he/she discontinues the course before completion.

4. The Bond obligations will not apply if the offer of appointment is not made by the Government within 1(one) year from the date of communication of the results specified in Sub-clause ix(a) of Clause-3 of the bond or the candidates accepts the offer of employment even after one year.

This is issued in cancellation of all previous Notifications issued in this regard and with the approval of the Government, vide U.O. No.F.1(23)- GA(CAB)/2007(1) dated 3rd August,2016.
