Notice Inviting Quotation

Sealed quotations in plain paper are hereby invited from transport agency/travel agent for Bolero/Scorpio/Sumo/Ecco vehicle having valid registration and commercial licenses from the Transport Authority for hiring 01 (one) vehicle **as on when required** for **Model Rural Health Research Unit (MRHRU)**, Kherengbar Hospital Complex, Khumulwng, Tripura.

TERMS and CONDITIONS

1. The sealed quotations addressed to **Member Secretary (MRHRU, Tripura State) Kherengbar Hospital Complex, Khumulwng, Tripura** superscripted "**Hiring of Vehicle**" on the envelope should reach to the office of the undersigned in the MRHRU Building, **Kherengbar Hospital Complex, Khumulwng, Tripura**, during office hours till 4:00 P.M. The sealed quotations will be received up to 3:00 P.M., on 15th Feb, 25. Quotation will be opened if possible same day.


Quotation is to be submitted in the form of application on a plain paper to the **Member Secretary** and has to be signed by the applicant and has to be mentioned that all terms and condition are accepted.

2. The vehicle has to be deployed as on when required by the authority.
3. No enhancement of rates within the valid period of the contract shall be entertained.
4. As and when required for the Project work, the vehicle has to be placed in time on receiving requisition over telephone at least 12 hours before the commencement of journey.
5. Cancellation of pre-scheduled journey will be intimated at least 12 hours prior to the commencement of journey over telephone by the concerned officials.
6. Rate will be valid for one year from the date issue of approved list.
7. The rate should be quoted both in figures and words for the following items:-
 - a. Night Halt charge
 - b. Detention Charge per day
 - c. Running charge per K.M.
 - d. Overtime beyond 08 (Eight) hours of duty per day mentioning rate per hour for extra work.

The above mentioned information may be submitted in the tabular form as mentioned below.

8. The cost of fuels, lubricants, spare parts and Insurance of the vehicle and remuneration of the driver of the vehicle is to be borne by the owner/agency.
9. During submission of rate, Photostat copies of PAN Card, GST Registration, Tex Clearance certificate and Trade License have to be submitted by the owner or agency.
10. The Log Book should be signed on the day of the duty mentioning date, kilometer reading and time of reporting and departure. Each journey should be certified by the P.I. / Research Scientist / project staff who avail the vehicle for journey. Bill claimed against the journey not duly certified will not be paid.
11. Whenever, the vehicle will be out of order/off road during the duty hours of the validity period an alternative vehicle should be replaced within 02 (Two) hours in order to avoid interruption of service.
12. The successful bidder should keep the vehicle with a driver for 8:00 A.M. to 5:00 P.M for the duty in the Hospital premises as and when requisition is placed. In no circumstances, the vehicle and the driver should be out of the Hospital premises without the permission of the authority on duty hours.
13. The vehicle will be utilized for field activity all over the State of Tripura.
14. In order to decide lowest bidder, total journey per day will be considered as maximum 50km. Following example is expected bellow/Detention charge per day including all taxes and charges Rs. X.00/km Running charges included all taxes and charges Rs.Y.00. Total amount for 50km running per day Rs. (X+50Y), this value will be considered at the time of preparation of comparative statement.
15. For field programme night halt may be necessary in some cases, separate rate for night halt to be coated.
16. The GST rate should be included the vehicle bill, as per Government Rule.
17. Payment will be made on monthly basis on submission of Bills in triplicate certified by concerned officials along with relevant up to date Log Book.
18. The undersigned reserves the right to accept or reject any or all quotation (s) without assigning any reason.
19. Any dispute, if arises thereof will have jurisdiction of Agartala High Court.
