2. Any quotation received after the aforesaid timeline shall be liable to be summarily rejected. The Medical Superintendent & HOD, AGMC & GBP Hospital shall not be liable in any manner for any delay occasioned or failure caused in delivering a quotation within the prescribed timeline as aforesaid.

The quotationers shall mention their full name, address and contact number on envelopes.

4. Quotations received in due manner are likely to be opened next day after end date of submission, in the Office of the Principal, AGMC, Agartala, unless postponed for any unfrozen reason. Quotationers can be physically present to witness the quotationsopening proceeding (no separate notice will be issued to this effect to any quotationer).

5. Self-attested photocopy of relevant up to dated & valid (i) Trade license (ii) Drug License (iii) Authorization certificate, (if bidder is not the manufacturer, authorization certificate from concerned manufacturer is to be submitted (iv) Manufacturing License (V) PAN Card (VI) GST Registration certificate & Last GST return copy/GST clearance certificate, (vii) Acknowledgement copy of Income tax Clearance certificate. The Technical (Tender Evaluation) committee of the hospital shall have the right to waive off any of the aforesaid requisites in deserving cases

6. Rate should be quoted inclusive of all taxes.

7. Supply of the medicines should be up to the destination (Medicine Store, AGMC & GBP Hospital, Agartala) at the earliest, but not later than 30 days after receiving Purchase order. Penalty @ 1% of the purchase value shall be deducted for every week (or part thereof) of delay in delivery beyond the stipulated date, unless condoned for. In case of supply of lab consumables of substandard quality or with any other defects, the supplier shall be liable for compulsorily replacing the same entirely at his own expenses within 15 days of notifying him to this effect.

During execution of supply orders, the manufacturers will have to submit the Test Report/Certificate of Analysis of Medicines/Drugs from the manufacturer itself and in addition they will have to submit the Test Report/Certificate of Analysis of Medicines/Drugs from NABL accredited Laboratory including validity certificate of the said NABL Lab. NABL report is not necessary for Imported Drugs.

9. If ordered quantity is less and the ordered value is less than Rs.50,000/- for each item, the medicine will be received with test report of manufacturer itself and the medicine will be tested at SDTL, Agartala for which testing facilities are available at SDTL. In

case the order amount is above Rs.50,000/- then NABL certificate must be submitted for each batch

10. Payment of bills will be made after successful completion of supply as per the terms and conditions of the concerned Purchase

11. The Medical Superintendent & HOD, AGMC& GBP Hospital reserves the right to unilaterally revoke or cancel this SNIQ at his discretion without prior notice; and to reject any quotation or to select a quotation other that the lowest one on justifiable grounds.

12. Approximate requirement is incorporated in the SNIQ which are likely to increase or decrease as per actual requirement. The supply order may be issued once for staggered supply as per requirement.
